1.	Authentication  As per the Terms of Reference, the preferred authentication method is Single Sign-On (SSO) authentication through Enabel's Azure AD identity provider. We need clarification on whether Azure AD is already set up at Enabel Uganda or if it needs to be implemented by the contractor.	Azure AD is already set up by Enabel Uganda through Enabel Global Office.  Note: Please note that using SSO thru Enabel AD is an option, not mandatory. You can propose an alternative method in your technical proposal.
2.	Mail server Since in the ToR it is mentioned that SSO will be implemented based on Azure AD, can we assume that the mail system is based on Microsoft solution (Office 365)? If not, could you please provide details about the existing solution?	Yes, the mail system is based on Microsoft solution (Office 365). More details to get from Inception Meeting.  Note: Using Azure AD is an optional feature.
3.	Customization  As outlined in the Terms of Reference, customization of the platform to meet Enabel's requirements in Uganda involves configuring integrations, styling, and other settings. Is there an existing	This shall be provided during the Inception meeting.
