## General Clarification note

Definition of MSEs:

With reference to the official classification of the Ministry of National Economy, MSEs are classified based on the number of employees and annual turnover, where:

- Micro Enterprise has a number of employees that ranges from 1 to 4, provided that the turnover does not exceed 100,000 USD
   Very Small Enterprise has a number of employees that range from 5 to 9, provided that the turnover does not exceed 200,000 USD
   Small Enterprise has a number of employees from 10 to 19, provided that the turnover does not exceed 500,000 USD

1	9/07/2024	Regarding condition (D) of the (1.1.1.) Admissibility of applicants (page 7 of the CIP), it is written that the applicant must be established or represented in Palestine, then in the footnotes (3), it is mentioned that this condition is optional. My question is, is it a requirement for the main applicant to be established or represented in Palestine? To be clearer, Bisan Center has a partnership with a Belgian NGO called "Solidagro", can Bisan apply for this grant alongside Solidagro?	The lead applicant must be established or represented in Palestine meaning to be established as a local organization. The articles of association of the organization should mention the establishment of the organization or the branch in Palestine. This means that the "umbrella" organization or the INGO can be established outside, if you have a locally established branch in Palestine. It would mean that there is an organization established in Palestine that has capacity to take on legal obligations on their behalf and that they offer equivalent financial and operational guarantees.
2	11/07/2024	Can the subgrants be provided and managed by a Co-applicant as well	The co-applicant can also provide sub-grants but the lead applicant remains responsible for ensuring the quality of the activity and must ensure that the criteria outlined on p12-14 are respected. In the application it should be clearly outlined who will provide sub grants, how the lead applicant will ensure oversight and how the criteria on p12-14 will be respected.

INGOs operating in East Jerusalem registered according to the applied law with the authorities in Jerusalem are eligible to apply as long as they meet all other eligibility requirements.

The initial planned duration of an action may not be less than 18 months nor exceed 22 months of implementation period. In addition, three months closure period needs to be added.

10	11/07/2024	Do SMEs need to be registered to receive support?	SMEs need to be registered with the Ministry of National Economy by the time they will receive the seed fund. If the SME needs additional registrations in order to operate their business, the (co- )applicant should support the SME in this process as part of the follow-up training and coaching.
