7.	Re 'The amount owed to the supplier must be paid within thirty days with effect from the expiry of the verification term' - what constitutes the verification term?	Upon inspecting the equipment, and we accept, we give you an acceptance report and then you issue the invoice with acceptance report. The said invoice will be paid within 30 days upon submission of the required documents.
8.	Does the performance bond remain in place for a further one year following provisional acceptance, ie until final acceptance at the expiration of the 1- year warranty period?	Yes and this shall apply per order. However, kindly note performance bonds shall be required for orders above 50,000 euros or whose delivery period is more than 45 calendar days.
